If a school has enough skiers to field a full Team B, that Team B will be eligible to qualify for OFSAA if they are the second place team based on NOSSA results".

6. Swimming (new section), Activity Calendar, 4-Year Calendar Add new Swim Playing Regulations to COED Section of Handbook

Whereas.

The SDSSAA Swim Championship has been acting as the OFSAA Swim qualifier for the last number of years,

And whereas,

Selected schools from the North Shore and Nipissing Districts have been actively competing in the SDSSAA Championship meet and several student-athletes from these schools have qualified for OFSAA competition as a result,

And whereas,

These same schools have hosted preliminary meets which demonstrates a commitment to the sport and the capacity to host a NOSSA meet,

And whereas,

It is not fair to place the onus on a single association to host the NOSSA championship year after year,

And whereas,

Without formal acknowledgement/acceptance from NOSSA to act as an OFSAA-qualifier, it remains to be determined whether or not OFSAA should even be accepting entries from the SDSSAA-hosted championship as it has been up until now.

APPENDIX "A" - PLAYING REGULATIONS SWIMMING

AGES:

As per NOSSA constitution – Article VII: Eligibility, Section 6 – Age Divisions

SERIES:

Boys: (a) Midget (b) Junior (c) Senior (d) Open Girls: (a) Midget (b) Junior (c) Senior (d) Open

TOURNAMENT DATE:

The championship meet will be hosted prior to the Christmas break each school year, at a date approved by district representatives attending the NOSSA resolutions meeting in April of the school year prior.

LOCATION:

The tournament location and convenership shall rotate amongst the participating districts.

OFFICIALS:

Volunteers, coaches, players, parents, or other responsible people who may be in attendance and/or may be selected by the convener.

RULES:

As per OFSAA. Starts, strokes and turns, for all strokes shall be as per the latest SNC regulations.

ENTRIES:

Entries will be accepted from the district convener only. Competitors may enter up to four (4) events; three (3) of which may be individual events. Each school may place an unlimited number of entries in any event if the swimmers meet the requirement of the category. However, only a maximum of two (2) swimmers per any school per event may advance to the finals. In the event that there are eight swimmers or less, all swimmers advance to the final round.

FINANCING:

Entry fees should be set on a per competitor basis. Amount of fee is left to the discretion of the convener but should be sufficient to cover all championship meet costs.

APPENDIX "A" – **SWIMMING REGS (cont'd)**

MEET STRUCTURE:

(a) Open Division

A swimmer who has competed for and/or trained with and/or been registered with a SNC club or equivalent as of November 1st of the year prior to the current school year shall be eligible to compete in the Open Division only provided that he/she is a bona fide member of the school team.

A swimmer who, during the current school year, has competed for and/or trained with and/or been registered with a non-SNC competitive swim club* shall be T-2 eligible to compete in the Open Division only, provided that he/she is a bona fide member of the school team. If a **grade 9 swimmer** has ceased to compete for and/or practise with and/or is no longer registered with a club after November 1st of the current school year, he/she shall be eligible to swim in the high school division.

A "non-SNC competitive swim club" is defined as a club which practices outside the school curricular and/or extra curricular programs and whose athletes compete in scheduled swim meets for the club during the school swim season.

(b) High School Division - Junior and Senior Events

All other swimmers (i.e. not Para-swimmers or Open swimmers as defined above) who meet the eligibility requirements as outlined in Regulation #7, and who are bona fide members of the school team compete in this division.

AWARDS:

Individual – NOSSA medallions shall be presented to the first two (2) finishers in each event.

Team - Banners will be presented to the Boys team scoring the highest number of points in the meet. and the Girls team scoring the highest number of points in the meet.

SCORING:

(a) The first eight places of the finals will receive points in each event.

TREASURER'S REPORT 2019

As I continue to track the NOSSA income and expenditures, the trend is indicative of a decrease in our year end bank balance. For the past three years, our expenditures have been greater then our income. This deficit is detrimental to NOSSA's ability to cover costs in a timely manner. As a result of this deficit, there is a need to increase NOSSA's income. NOSSA medal costs for the championships, a direct charge back to all NOSSA schools, and/or an increase in FTE fees are some of the ideas that we have been considering in order to increase NOSSA's income.

One of our largest expenditures is the Commercial General Liability (CGL) Insurance. As per the NOSSA Constitution, the cost of this insurance "will be offset in part or full with rebate revenues" from InnVest Hotels. We continue our partnership and rebate agreement with InnVest Hotels, however, over the past few years our rebate has decreased significantly. This decrease in rebate amounts will reflect on the NOSSA schools paying more for this insurance. I encourage you to utilize the hotels (listed on the NOSSA website) that are included in the InnVest Hotels Rebate Program. OFSAA Report to NOSSA Delegates 2018-19

Firstly, Kim Chezzi and I – Tim Lowe (NOSSA representatives to OFSAA Representative Council) would like to thank all NOSSA delegates for attending today's meeting. We would also like to thank the North Shore for hosting the meetings as well as the Hospitality Suite last night. We would be remiss in not thanking a few individuals that perform the unenviable task of essentially running NOSSA – Dave Makela Laura Aubertin and Heather Chambers deserve our thanks! As well, the NOSSA District Secretaries and Presidents that also lend a hand in the smooth operations that NOSSA has always been.

We would also like to thank Yves Poirier, the NOSSA Prinicipal's Representative to OFSAA at the AGM. He's a wonderful addition with not only his professionalism and integrity, but also with his charismatic personality and sharp wit. He'll be taking on a more involved role at the OFSAA meetings as he will be the Principal's Rep for the North Region – Congratulations Yves. As well, Peter Kategiannis attended the AGM (in place of NOSSA President Nigel Good) – thanks Peter for providing us with your valuable insight.

Secondly, we would like to congratulate all the athletes, teams and coaches that represented our association at the various championships. It's nice to go to the meetings and know that not only do our teams perform well; they are also very well behaved, which is a true testament to the quality and leadership of our teacher/coaches.

As for hosting OFSAA championships, our association took on the task of hosting Girls A Basketball, Badminton, Boys and Girls Curling and Boys AA Soccer. All four event were (or will be) well run and received nothing but positive feedback from all those that attending.

In 2019-20, NOSSA will be hosting OFSAA Cross Country Running in Sudbury (Karen Passi); Wrestling in Sault Ste Marie (Trevor Manchester) and Boys "A" Basketball in North Bay (Brandon Grube)

The OFSAA Conference is being held at Durham College in Oshawa on May 9 & 10. Denise Perrier has been working very hard at providing us with a fantastic guest speaker list highlighted by Scott Russell of the CBC. Please share this info with ANYONE who you feel could benefit from this Conference. Contact Denise through the OFSAA Website.

The CIAAA and OFSAA are continuing their partnership – now into its 3nd year - to provide support and professional development for athletic coordinators/directors within secondary schools across Ontario. There have been several courses already delivered. Denise Perrier is the lead contact with this initiative and he can be reached at the office. They have run numerous courses to over 200 Athletic Directors around the province with many more courses planned before the end of the year.

There were many changes to OFSAA By-laws and also to various playing regulations at our recent AGM and we've highlighted them below. As well, the full Order Paper, with the outcome of the motions, can be viewed on the NOSSA Website. Regarding this, both Kim and I cannot emphasize this enough that its absolutely imperative that Program Leaders, athletic heads of departments and other teacher/coaches read and review the OFSAA Order Paper and provide us with feedback to assist us in voting.

OFSAA AGM highlights:

- Co-Ed Ultimate will be an official OFSAA Sport as of next year. Much debate occurred regarding
 where to place the Championship (Fall or Spring). The issue will be resolved by the Executive
 Council in June 2019.
- Changes were made to the Twinning Bylaw, specifically as it pertains to school population and Football (Now can occur when a school's population in under 240 (old regulation was 100).
- Student-athletes who play on a school prep/elite team (that is endorsed by the school) and then are no longer on that team but remain at the school, are ineligible for the 'bona fide' school team for the current school year and the following school year.
- Midget category for competitions will be changed to NOVICE in Cross-Country and Track & Field.

- Transfer changes:
 - 1. A(ii) The student has transfer to an Ontario school from outside Canada AND outside the United States and is attending the designated school in their choice of system (public, catholic or independent) according to school board boundaries; or is attending the closest school in the student's choice of system to the student's home if no school boundaries exist; or is attending a school assigned by the school board.
 - 2. D the student must attend the next closest school to their home residence if remaining in the same system. If changing systems, the student must attend the designated school according to school board boundaries (or the closest school to the student's home residence if no school boundaries exist).
 - 3. That NOTE 10 be added to the b(iii) and applied as such. *what is that again?
- The covering of club insignia/logo be at the discretion of the Championship Protest if a safety hazard is determined to be present.
- Changes to the Gender-Equity policy in order to show that the policy has evolved to more inclusive language and therefore changing the language to Student-Athlete rather just using the word 'female' or 'girls' or 'women'.
- Also, changes regarding the language regarding lived gender rather than 'for girls and boys'
- Removal of Appendix IX of the Transgender Policy as the Gender-Equity Policy now covers this
- That OFSAA Advocacy Committee be added to the OFSAA bylaws and to Appendix XI OFSAA Ad-Hoc Committees.
- Football be permitted to have 65 participants per team at the OFSAA Football Festival.

Changes to Playing Regulations:

- Alpine Skiing changes to the team entries. Host Association be permitted extra entries as the host.
- Appeals date for Badminton now set for April 1st of the school year. It was Feb 1st, which was too early in the season.
- Badminton Open division players cannot move into the C flight and high school division participants in matches 25-48 move into the First Round of C flight.
- Badminton max entries of 2 per event, with one entry into the H.S. division with additional entries being based on previous years medal placings. (No player can enter more than one event).
- Changes were made to the draw so that no player can be eliminated on the first day of competition and all competitors be granted a minimum of 3 matches.
- Cross-Country: changes to exclude the 6th and 7th runners as individual qualifiers Each association has 2 team entries and 5 individuals (who aren't a member of the representative schools/teams in each of Novice, Junior and Senior).
- Football changes made to HOW the bowl games are set up (no two associations shall play each other in back to back years; increased participation limits 65; disciplinary actions from the association shall carry forward to the Bowl; minimum numbers of games for Bowl-competing teams is 6 if no association championship exists; visiting team will change uniforms if a conflict exists;
- Hockey officials be qualified with a recommendation of a Level 3 official for all games; BOTH -3 person system for all round-robin (pool) games; BOYS –minimum 3 person system for playoff games but a 4 person system is recommend for quarters, semis and finals; GIRLS -3 person system MUST be used for quarters, semis and finals; BOTH-Head Official (or designate) must be present at the coaches' meeting.
- Nordic Skiing no application of high fluoro powder or hardening powders at the assigned OFSAA Waxing venue
- T&F Steeple heights for OPEN girls (30 inches) and OPEN boys (36 inches); Up to 6 members of the relay team will receive medals/ribbons if they finish in top 8 as long as they've been registered; new rotation for hosting OFSAA (allows the North Region to be added with 2 years notice).
- Volleyball Tie-Breaking rules changed
- Wrestling host association will be permitted 1 extra entry in any weight class that is not full.

Items of General Interest:

- Major changes with regards to OFSAA sponsorship and championship clothing: currently in negotiations with a single retailer that will provide clothing for all OFSAA championships (minus Track and XC) offers consistency in pricing and quality of products as well as Host Committee Revenues.
- Also currently negotiating Major Branding Sponsorship not necessarily Sport or Sporting Goods related.
- If your team (or school's team) has qualified for an OFSAA championship, please adhere to the entry deadlines. If you feel we cannot (for various reasons) please contact either Kim or myself.
- Colin Hood School Sport Awards info available please use the contact page on the OFSAA Website–deadline for order is April 30!- SOON
- At the CGA it was stressed that OFSAA hosting committees should really pay attention to the Gender equity in nominating the Leadership in School Sport Award. We're noticing that not enough women are getting the recognition for the time they spend developing student-athletes in their respective sports.
- Please fill in the Survey Monkey for Fall and Winter participation stats. These stats are important for OFSAA to continue receiving their grants from various gov't ministries.
- For all OFSAA Programs, please visit the website at www.ofsaa.on.ca for information regarding Try Day, Bridging the Gap, KidSport Financial Assistance, Coaching in Ontario Schools (CIOS), Scholarships and the Officials Clinic Subsidy Program.
- The Three Year Calendar for OFSAA championships is ALMOST complete for the 2018-19 school year. If you'd like to host a championship for 19-20, 20-21 or 21-22, please contact Kim or myself. You will be required to fill out The Championship Bid Process Form that is available on the Website.
- A reminder that the entry structure for all OFSAA championships will guarantee 1 entry per Association.
