#### **BADMINTON MOTIONS for 2022 NOSSA AGM:**

#1 - Reference - COED Playing Regulations, page 2

Under FORMAT, eliminate (c) in its entirety.

Kim Lidstone (Korah) – Lizette Langois-Rheault (N-Dame)

Rationale: 10-12 courts are not always used to host NOSSA, but regardless, the number of courts is

irrelevant. For as long as I have been involved in badminton, I do not recall anybody ever running the tournament this way. Typically Singles, Doubles, and mixed are all played

together so that they finish together and then we have our awards ceremony.

#2- Reference – COED Playing Regulations, page 3

Under FORMAT, section (f)

Reads presently: "Games one to eight in each draw are to be played on the Friday evening".

Change to read as follows: "NOSSA Badminton will take place on a Thursday/Friday, 2-3 weeks before OFSAA, with Games 1-8 in the draw being played on the Thursday night."

Rationale: Reflects actual practice.

#### 1. Cross Country

Reference: Eligibility

Add to section as follows: "Athletes must compete in the same age category for both the district championship and NOSSA championship. As per Nossa Constitution Article VII: Eligibility, Section 4: Participation requirements b) A player may not play in one age division in District play-offs and another in N.O.S.S.A.."

#### 2. Curling

**Reference: Time-Outs** 

In the event of a tie at the conclusion of a game, an extra end towards the home end shall be played until such time as a winner is declared. If the game goes into extra ends, there shall be a three (3) minute break for consultation between the coach and curlers at the end of the eighth end. Each team may call one 60-second time-out during each extra end. Time-outs shall not be carried forward to the extra end(s) or from one extra end to another.

David Gallant (Espanola) – Joey Dimaio (Notre-Dame) Action: CARRIED.

Rationale: Brings the rule in line with OFSAA playing regulations.

#### 3. Curling

**Reference: Time-Outs** 

The Coach of the team that called the time out may access the playing surface. Neither the Coach or team members may confer in the house. Coaches must wear appropriate footwear to access the ice surface.

David Gallant (Espanola) – Joey Dimaio (Notre-Dame) Action: CARRIED.

<u>Rationale</u>: Rocks could be moved with five people standing in the house. Standing in one spot for a prolonged period of time could damage the ice surface.

#### 4. Curling

Reference: Add the following

Each team's draw to the button for the first four round robin games will be measured in cm. A rock covering the button will be measured as zero (0) cm. Rocks that are not in the house receive a measurement of 185 cm. The sum in cm of all of a team's draws to the button will be used for tiebreaking.

Reads presently: "Set up with 2 Pools of 4 teams in a 2-day event on 4 sheets of ice"

Change to read as follows: "At a minimum set up 2 pools of 4 teams in a 2-day event on 4 sheets of ice. If a club has 5 sheets—use 4 sheets. If a club has 6 or 8 sheets draw can be modified so boys and girls play at the same time but same format".

Joey Dimaio (Notre-Dame) – David Gallant (Espanola)

Rationale: At present there is no allowance to change the draw if more than 4 sheets of ice are available at the chosen Curling Club. By modifying the basic layout for 6 or 8 sheets Day 1

and Day 2 of the event can be started and finish at more reasonable times. Also, this allows the Club to still generate financial gain from their league play which is normally held after

6:00p.m. Travelling teams will be able to travel back home earlier.

#### 6. Golf

**Reference: Eligibility** 

Add to existing section as follows: "Only those male golfers who recorded an aggregate score of 110 and female golfers who recorded an aggregate score of 120 at their respective district competitions will be deemed eligible to participate".

#### 7. Tennis

Reference: Entries, page 33

**Reads presently:** The NOSSA Tournament shall be a (4) four team single elimination tournament with each district guaranteed one entry. When only two (2) districts compete in an event, each gets two (2) entries. When three (3) districts compete in an event the host district gets two (2) entries.

**Revise to read as follows:** The NOSSA tournament shall be a four (4) team round-robin tournament with each district guaranteed one (1) entry. No playoff match will be played. If there is a tie between teams after the round-robin, the head-to-head matches between the tied teams will be the tiebreaker. If teams are still tied, the number of games will be looked at to break the tiebreaker.

In the case that an event has two (2) or less entries, the Open and High School divisions will be combined for the competition but will still qualify for OFSAA in their respective divisions.

When only two (2) districts compete in an event, each gets two (2) entries. When three (3) districts compete in an event the host district gets two (2) entries.

The NOSSA tournament will have two (2) divisions, as there is at OFSAA; there will be the Open Division and the High School Division.

**Open:** An Open Division player must have won a minimum of two (2) rounds in total (one [1] round or more in a tournament and/or at a later date wins a round in another tournament) in 3-star Ontario Tennis Association (OTA) tournaments or higher or the equivalent (USTA, European Championship) in the three years prior to the beginning of the school year. Any player who has ever played in the Canadian Nationals or any players that has ever played in any U-14, U-16, or U-18 provincial championships shall also be considered an open player. A bye, defaulted or retired match in an OTA event does not constitute a win.

**High School:** any player who has not met the above criteria for an Open player.

This means that each district may submit one (1) entry into the Open division (only if they legitimately qualify as an Open athlete), and one (1) entry into the High School division per category.

The convener may also decide upon the length of sets depending upon time available. This will depend upon the time available and the number of courts available). Finals will be 10 game sets "with ads". Tie breaker at 9-9. If challenge match is required, play 8 game pro set with tie breaker at 7-7".

**Revise to read as follows:** "All matches will be an 8-game pro set, using no-ad scoring. Tiebreaker will be played at 7-7".

#### Revise to read as follows:

There will be gold medals for each division winner, silver for second place finishers and ribbons for third and fourth place finishers. There will also be a championship banner for the school with the most overall points in the high school division. The following breakdown will be used to award points based on finish:  $1^{st} = 10$  points,  $2^{nd} = 7$  points,  $3^{rd} = 4$  points,  $4^{th} = 2$  points

If there is a minimum of three (3) Open players/teams, then an Open banner will also be awarded using the same points system.

In the event of a tie for points, the school with the most 1<sup>st</sup> place finishes will win the banner, if still tied, then the school with the most 2<sup>nd</sup> place finishes wins the banner and so on until the tie is broken.

### **TREASURER'S REPORT 2022**

As the NOSSA Resolutions Meeting and Annual General Meeting is held virtually through ZOOM, we continue to improve our financial picture. In May of this year, will be clearing our loan from SDSSAA and will retain a small amount of funds. These meetings are a significant amount of our expenditures. A motion has been put forward to place this financial responsibility on the AGM host district. The host district is currently responsible for organizing these meetings according to the NOSSA Constitution requirements. NOSSA does generate funds from FTEs, medal purchases, INNVest Hotels Rebate and INNVest Hotels Web Sponsorship. These fees generally go toward awards that are presented at the AGM, insurance (Risk Insurance and Directors Insurance), OFSAA SAC Meetings, Service Charges and Operating Expenses.

Our INNVest Hotels Web Sponsorship was not collected last year as the Executive felt that due to NOSSA not holding its championships, INNVest Hotels did not benefit from its sponsorship. Also, this year, the Executive decided that collecting half the sponsorship amount was fair to NOSSA and INNVest Hotels as NOSSA held a reduced number of championships. INNVest Hotels have a link on NOSSA's web page that makes convenient to book hotel rooms. NOSSA receives a rebate for these bookings and you can save up to 15% off the cost. A list of participating hotels is included. A reminder to NOSSA Convenors to "include the current information and links that are provided by INNVest Hotels and promote the booking of accommodations that are designated for rebate to NOSSA." as per our constitution.

Due to the uncertanty of holding NOSSA Championships these past two years, the invoices for NOSSA medals were delayed. As a result, some of the funds for NOSSA Awards will not be reflected in our Balance Sheet until next year. As well, NOSSA received a short term loan to cover the cost of the medal invoice from King Sportswear. This loan will be repaid once all the Awards moneys have been received. Thanks to Dave Makela for sorting out this issue.

I would like to thank the District Secretaries for their assistance and cooperation and to all NOSSA members for your continuing support of secondary school athletics.

### 2022 N.O.S.S.A. REPORT FROM THE SECRETARY

Reviewing last year's report chronicling the cancellation of the 2020-2021 high school sports season as a whole, I think that 2021-2022 might be viewed as an improvement, but certainly nowhere close to what we might consider a "normal" championship season.

Of the forty championships planned, thirty managed to proceed, albeit with reduced numbers of teams/participants due to covid-related concerns. Fall sport OFSAA championships also proceeded with smaller numbers but their winter sport counterparts were cancelled, and with a covid-related paused inserted in the middle of local seasons, most NOSSA winter sport championships were rescheduled and caused local seasons to extend beyond March break.

Those regional championships that managed to proceed were hosted with the best intentions and provided the best competitive experience to student-athletes that was possible under the circumstances. To this end, NOSSA is grateful to local conveners who stepped forward on short notice to fill whatever gaps they could in the activity calendar.

Though recently an uptick in covid variants BA1, BA2 and now a hybrid XE is being recorded, hopes are high that from this point forward, the championship spring schedule will be able to proceed unabated and to this end, a full slate of OFSAA Spring Sport Championships are being planned.

Looking ahead, the NOSSA web calendar will continue to be the sole source for NOSSA championship event info during the 2022-2023 school year. Once information has been received from local conveners, it will be linked to the calendar and updated when necessary.

Starting in the fall, any tournament information I receive will simply be forwarded to the NOSSA email contact list. Any tournaments hosted by NOSSA schools will be featured in the NOSSA web calendar as well.

District secretaries are requested to forward any information shared to the coaches in their respective districts who could not attend the AGM to keep them updated on NOSSA policies and procedures. District Secretaries are also requested to pass along any changes to their school contact information so email contact lists can be kept up-to-date.

Finally, to those members retiring this year, all the best in your "second careers" and sincere thanks are extended as always for your generous and invaluable support over the years.

The CIAAA and OFSAA are continuing their partnership — now into its 5th year - to provide support and professional development for athletic coordinators/directors within secondary schools across Ontario. There have been several courses already delivered. Jim Barbeau is the lead contact with this initiative, and he can be reached at the office. They have run numerous courses to over 200 Athletic Directors around the province with many more courses planned before the end of the year.

The OFSAA Virtual Coaches' Café and OFSAA Student Forums have been a big success sand are a silver-linings from the Pandemic. Kim and I, will continue to send you updates with regards to these types of initiatvies offered by OFSAA

There were a few changes to OFSAA By-laws and also to various playing regulations at our recent AGM and we've highlighted them below. As well, the full Order Paper, with the outcome of the motions, can be viewed on the NOSSA Website. Regarding this, both Kim and I cannot emphasize this enough that its absolutely imperative that Program Leaders, athletic heads of

departments and other teacher/coaches read and review the OFSAA Order Paper and provide us with feedback to assist us in voting. OFSAA AGM highlights:

Doug Gellatly is retiring at the end of the year. His replacement will be chosen by the end of May in order to assure a clear and concise transition. He has been instrumental in keeping OFSAA relevant and up to date within our province. He will be missed, but we wish him well in his well-earned retirement.

• Girls Slo-Pitch will be an official OFSAA Festival as of next year. It will be played in the Spring.

Due to safety concerns, Wrestling has adopted new and more definitive weight classes in the OFSAA playing regulations. As well, they've adopted a much more comprehensive scoring system for team championship points.
