Article 8 – Amendments

Section 1

The Articles may be amended at the Annual Assembly in April, by two thirds (2/3) of the votes cast (excluding abstentions) of the entire membership (Executive Council, Representatives' Council, Presidents' Council, Principals' Council) No member shall have more than one vote.

By-Law 9 – Amendments Section 1

a) The By-Laws may be amended at the Annual Assembly by two-thirds (2/3) of the votes cast (excluding abstentions) of the entire membership (Executive Council, Representatives' Council, Principals' Council, Presidents' Council). No member shall have more than one vote.

Section 2

- a) The Standing Rules general sections of the Playing Regulations relevant to all Championships, (i.e Social, Awards, Uniform, Deportment, Supervision, Jury of Appeal, Competition Committee, etc.) other than the "Rules of Play", governing competition in the various Championships sponsored by the Federation can be amended by a two-thirds (2/3) of the votes cast (excluding abstentions) of the entire Executive Council, Representatives' Council, Principals' Council, Presidents' Council). No member shall have more than one vote.
- b) The Standing Rules sport specific "Rules of Play" (i.e. Rules and Officials, Uniforms and Equipment, Seeding) governing competition at the various Championships sponsored by the Federation can be amended by two-thirds (2/3) of the votes cast (excluding abstentions) of the Representatives' Council. No member shall have more than one vote.

Page B6 & B7, Bylaw 3 – Committees, Section 1 (a)(e) – Committee for Boys, Section 2, (a) (e) Committee for Girls

WHEREAS According to the Ontario Education Equity Action Plan, systemic barriers are caused by embedded biases in policies, practices and processes, and my result in differential treatment. Barriers can be unintentional; often these are the result of doing things the way they have always been done. Regardless of the reason for them, their impact can be detrimental to many.

Page B21, By Law 5 - Eligibility for Competition, Section 4 – Individuals,

WHEREAS Intellectual Para athletes have been excluded from some high school sports due to their age even though they are legally allowed to be in high school until their 21st birthday.

AND WHEREAS Intellectual Para Athletes are only allowed to participate in three (3) high school sports past their 19th birthday; Cross-Country-Para, Swimming-S14, Track & Field-T20

AND WHEREAS Intellectual Para Athletes are asking to be able to participate on any high school team using their abilities after their 19th birthday since they are still allowed to be in school. They want to be part of a school team. The numbers of Intellectual Para Athletes are very few, but allowing these athletes the opportunity to participate can make a world of difference for them.

AND WHEREAS These Intellectual Para Athletes are listed in the overall school numbers in which every school pays sport fees to local associations and OFSAA.

AND WHEREAS Inclusivity for ALL athletes and their abilities to participate in sport is the essence of OFSAA's motto of "Education through Sport."

AND WHEREAS There is also a need for a specific definition of what an Intellectual Para Athletes is under the Competition By-laws of OFSAA so that all coaches are knowledgeable.

BE IT RESOLVED THAT By -Law 5 - Eligibility for Competition, Page: B21, Section 4 – Individuals, insert at a) vii)

Intellectual Para athletes will be permitted to compete until the age of twenty-one (21) in ALL sports and shall be eligible for no more than seven (7) consecutive years from the date of entry into Grade 9.

An Intellectual Para Athlete is defined as a person(s) having restrictive intellectual functions and adaptive behaviours that affect their conceptual, social and practical adaptive skills required for everyday life. The impairment must be present before the age of 18. They will have been placed in a Special Needs Program through an IPRC, has an IEP, not eligible to receive an OSSD and has an IQ of 75 or lower. Verification of their classification may be provided by their home school's Administration.

AND WHEREAS The current OFSAA Transfer is Policy discriminatory in practice with respect to race, gender identity, social economic status, gender expression, family status and place of origin.

Page B23, Bylaw 5 – Eligibility for Competition, Section 4 – Individuals g) The Federation's Transfer Policy d) – new (vi).

WHEREAS The Board of Reference – Transfers reconsidered the motion and is proposing the following amended motion. The committee believes an appeal section of the transfer policy is crucial for students suffering from mental illness.

AND WHEREAS there is currently no section in the transfer policy to allow for eligibility in cases where a mental health professional recommends a student transfer schools for mental health reasons;

BE IT RESOLVED THAT a new section d (vi) be added to the transfer policy which shall read: The student has transferred schools as a result of the recommendation of a regulated mental health professional with education and training to assess, diagnose, and treat mental health conditions (psychiatrist, psychologist, and/or clinical psychiatric nurse). Prior to transferring, the student must have been diagnosed with a mental health condition and be undergoing treatment by the regulated mental health professional. Documentation must be provided by the mental health professional confirming the student is receiving treatment and **requires a change in schools to assist with their recovery**. Unless otherwise confirmed in writing by the mental health professional, the student must attend the next closest school to their home residence if remaining in the same system. If changing systems, the students must attend the designated school according to school board boundaries (or is the closest school to the student's home residence if no school boundaries exist). If the independent school is faithbased, the student must attend the closest independent school of that particular faith.

Page B26, Bylaw 5, Section 4, new (i)

WHEREAS the Ministry of Education have approved Remote Learning Schools as a learning option for students within our associations.

AND WHEREAS students in remote learning schools would not have an opportunity to participate given the unique nature of the schools programming.

AND WHEREAS OFSAA wants to create more participation and inclusion for student athletes.

Students enrolled in an Ontario Ministry of Education approved Remote Learning School are eligible for participation at a Championship/Festival coordinated by the Federation, in any Federation sanctioned event, or in competitions outside of Ontario where participation of student-athletes has been sanctioned by the Federation, students enrolled at a Remote Learning School must:

- Be eligible for competition under the Constitution, By-Laws and Standing Rules (Playing Regulations) of the Association to which his/her school belongs.
- Be certified as eligible by the Principal of the Remote Learning School.

- Students in grades 10-12 will be granted eligibility if they choose to participate at their
 previous home school (the school where the student was enrolled the previous school
 year). If a student chooses to participate at a school they did not attend the previous
 school year, the student would be considered a transfer student and subject to the
 OFSAA transfer policy.
- Students in grade 9 must participate at the next closest school to their home address according to the Remote Learning school board boundaries.

MOTION: ANNETT /CORBIN

Page H-1, Section 3 (c) Football Playing Regulations (Entry)

WHEREAS High school football teams with over 56 players on the roster are not uncommon. Many Ontario high school football teams had over 56 players on their roster over the past few seasons (e.g. Korah Collegiate in 2021 and 2022, Holy Cross [Kingston] in 2021 and 2022). It is commonplace in the US to see high school football rosters with over 60 and even 70 players. Most of these teams also have staffs of 15 to 20+ (coaches, medical personnel, equipment managers, hydration, etc.).

AND WHEREAS Bringing over 56 players to an OFSAA Football Bowl game would result in zero additional costs for the OFSAA hosts / convenors. There is no OFSAA Football banquet and there were no hats or t-shirts given to players at the last two Football Bowl series events. All additional costs incurred would be the responsibility of the individual team.

AND WHEREAS It would be disheartening for a student-athlete who committed to their football team for a full season (or even multiple years of high school) to learn that they cannot be with their team at an OFSAA Football Bowl game due to arbitrary roster limit rules.

AND WHEREAS The intent of the 56-player roster cap rule at OFSAA Football is understood. It would be unreasonable to have an unlimited number of players & coaches on the sidelines for the Football Bowl games. However, increasing the maximum football roster size from 56 players to 60 players would reduce the likelihood of a student-athlete being excluded from participating in the OFSAA Football Bowl Series.

BE IT RESOLVED THAT Section 3 (c) – Football Playing Regulations (Entry) be replaced with: Each team may register a maximum of **sixty (60) players and up to ten (10)** team personnel on their AELS. Only registered participants may represent the school and/or attend Championship activities. (ref. Appendix XIV)

*If approved, this would require an edit to APPENDIX XIV on page B-65 (see below table). The number of participants in the chart on page 65 would need to be changed from 65 to 70.

WHEREAS Page H-2, Section 5 (a. iii) Football Playing Regulations (Entry) currently states: -

iii. Participate in the Association Championship or qualifying event. If neither is held, then the team must play a minimum of six (6) games against Ontario High School 12- man football teams.

AND WHEREAS Football as a sport has fallen on hard times in Ontario. In 2019 there were more than 250+ high schools playing Senior/Varsity. Since returning from the pandemic the number of participating teams has dropped well below 200.

AND WHEREAS in 2016 the OFSAA football S.A.C. put the 6 game (vs. Ontario 12-man high schools) recommendation into the football playing regulations, they never imagined we would be in the situation we're in today. Back in 2016 every OFSAA football region had a healthy league with multiple teams.

AND WHEREAS In 2022 the YRAA had no football conference. However, Huron Heights managed to play 9 games and scrambled to acquire 6 games vs Ontario 12-man high schools. Huron Heights was lucky. Three Ontario conferences happen to have an odd number of teams and hence, had by-weeks. For 2023 there is no guarantee any conference in Ontario will have an odd number of teams and even then, they are not required to play exhibition games.

AND WHEREAS Exhibition games can be found throughout Ontario for the first 3-4 weeks of September. But once we get to Thanksgiving it's very, very difficult to find teams to play; and once we hit late October, it is nearly impossible. No one wants to play an exhibition game heading into playoffs. Finding 4 games vs. Ontario 12-man high school teams is doable.

BE IT RESOLVED THAT H-2 Sec 5 (a. iii) - Football Playing Regulations (Entry) be replaced with:

iii. Participate in the Association Championship or qualifying event. If neither is held, then the team must play a minimum of six (6) games, including a minimum of four (4) games, against Ontario High School 12-man football teams.

WHEREAS Currently Section 5c, (i)(ii) states:

i. No competitor is eligible for the OFSAA Hockey Championship whose name has appeared on a game sheet, after his local high school first regular season game, for a team in "A", "B", "C", Major Junior, Junior, Intermediate, Senior or GMHL divisions in any National and/or International Association, or any league deemed equivalent to "A", "B", "C". This includes any on-ice All-Star or Showcase game organized by leagues/associations named in this clause.

ii. A Junior "B" or "C" team is allowed to AP a high school goalie to be called up in an emergency situation and appear on a game sheet and/or play up to a maximum of two exhibition/league and/or playoff games in total during the season after the Association's first regular season game. An emergency situation would not include an on-ice All-Star or Showcase game organized by leagues/associations named in 5c(i).

AND WHEREAS with declining enrollment across many parts of the Province, high school hockey teams are having a difficult time in mostly rural communities icing a high school hockey team.

AND WHEREAS allowing for Junior C players to become eligible to compete in high school hockey would increase participation and possibly allow for schools to have a high school hockey team.

AND WHEREAS the eligibility requirement for boys' hockey should no longer include ineligibility for Junior C players.

BE IT RESOLVED THAT all references to Junior C be removed from Page K-2, Sections 5c(i) and 5c(ii).

WHEREAS In snowboard racing, a limited number of Alpine boards (also known as plate boards) show up in competition and occasionally in the High School Level (Level 1).

AND WHEREAS Alpine boards give a tremendous advantage in speed to the rider compared to the regular park boards ridden by the vast majority of high school level riders.

AND WHEREAS Alpine boards use hard boots similar to a ski boot, not soft boots like a park boarder would wear. Hard boards have a different, downhill orientation for the rider and riders initiate a turn in fundamentally different ways than a traditional park board.

AND WHEREAS Alpine boards are built to carve precise turns at high speed on hard packed snow. As such, they give an unfair technical advantage when raced against riders in soft boots on park boards. It was agreed that this process would be used for the 2022-23 Championships only and that the Time Standards qualification process would return as the method of qualifying for the 2023-24 Championships.

- 2 (f) (i) Time standards shall be used as a requirement for entry to the OFSAA meet for those swimmers who do not win their event at the Association; official splits will be recognized as official entry times.
- 2 (f) (ii) If more than 34 swimmers qualify for an event, the new qualifying time for the next OFSAA Championship will be 1% faster than the current qualifying time. If 30 to 34 swimmers qualify for an event, the qualifying time remains unchanged. If less than 30 swimmers qualify for an event, then the new qualifying time is 1% slower than the current qualifying time.
